

- ADDITIONAL HOURS: Upon signature, I agree to pay additional hours beyond the coverage amount. Prepaid hours are at a rate of \$300.00 per hour. Prepaid hours must be paid 30 days prior to the wedding. * _____ Initial Here
- ADDITIONAL HOURS: Upon signature, I agree to pay additional hours beyond the coverage amount. Additional hours billed on the day of the wedding are at a rate of \$400.00 per hour. * _____ Initial Here
- STUDIO is not obligated to perform any service described in this agreement for the Client if payment is not made as outlined on page one of this agreement.
- No part of any order, including previews will be delivered until the balance is paid in full.
- There is a \$30 return check/non sufficient funds fee.
- Studio/Photographer may substitute another photographer to take the photographs in the event of Photographer's illness or of scheduling conflicts. In the event of such substitution, Studio/Photographer warrants that the photographer taking the photographs shall be a competent professional.
- If the Studio/Photographer cannot perform this Contract due to fire or other casualty, strike, act of God or other cause beyond the control of the parties or due to Photographer's illness or emergency, then the Photographer shall return the retainer to the Client but shall have no further liability with respect to the Contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event the Studio/Photographer fails to perform for any other reason, the Studio/Photographer shall not be liable for any amount in excess of the retail value of the Client's order.
- The Studio takes the utmost care with respect to the exposure, editing and production of all products and services offered. Every effort will be made to assure satisfaction according to the Studio's professional standards. However, the Studio is not responsible for subjective interpretations of photography.
- It is the Client's responsibility to see that the persons to be photographed are available, on time and cooperative.
- Weddings and events are dynamic and fast moving. While we make the best effort possible, we do not guarantee that everyone will be photographed, nor do we guarantee the exact number of images of any one person at the wedding, or the exact total picture count.
- Wedding coverage is contiguous. With four or more hours of coverage, Client is requested to provide a meal for Photographer and Assistant (if applicable.)
- Client shall agree that image, print and/or album selections will be completed and submitted to the photographer within 6 months of the wedding date. Any image, print and/or album selection orders placed after this period will be charged at current studio prices.
- Supply of products by outside manufacturers may change at any time which may be beyond your control. In that event, substitutions may be made.
- Basic facial blemish and stray hair retouching is subject to \$25 per subject per image. Additional retouching requires a custom quote.
- The Studio/Photographer reserves the right to use negatives, digital files and/or reproductions for advertising, display, publication or other purposes. Negatives and/ or digital files remain the exclusive property of STUDIO.
- "High Resolution Digital files" are available for an additional fee and include a release to obtain unlimited reprints for personal use. Files are optimized for a photo lab to reproduce an 8x12 print and are not retouched. High Resolution Digital Files included with a wedding album purchase are available and deliverable when the completed album is delivered and accepted by the client.
- Product credit has no monetary value outside of Studio's product and services.
- RETENTION OF DIGITAL FILES: Client agrees to place their final paid order within 180 days, after 180 days all orders will be considered complete and images disposed of.
- Upon signature, the Photographer shall reserve the date agreed upon, and will not make other reservations for that date. For this reason, all retainers, partial payments and fees including payments made by a third party in the name of the bride or groom, are nonrefundable and nontransferable for any other service even if the date of the EVENT is changed or the EVENT is canceled for any reason.
- METHOD OF CANCELLATION: In the event of a cancelled or rescheduled wedding, Studio requires notification in writing signed by the contracted party sent via Certified Mail by the United States Post Office, prior to the wedding date. This is the method of cancellation agreed upon by all signing parties and the only method of cancellation that will be accepted.
- In the event of a cancellation or postponement within 60 days of the event, the total amount of the contract is due as scheduled and is nonrefundable.
- The charges in this Contract are based on the Studio's Standard Price List. This price list is adjusted periodically. Future orders shall be charged at the prices in effect at the time when the order is placed.
- NOTICE OF COPYRIGHT: It is illegal to copy, scan or reproduce these photographs, digital files or images without Studio's/Photographer's written permission. Violators of this Federal Law will be subject to its civil and criminal penalties.
- This Contract incorporates the entire understanding of the parties. Any modifications of this Contract must be in writing and signed by both parties. Each Client signing shall be fully responsible for ensuring that full payment is made pursuant to the terms of this Agreement. The parties have read this Agreement, agree to all its terms and acknowledge receipt of a complete copy of the Agreement signed by both parties. This contract is governed by the laws of the state of Pennsylvania.
