

**Agreement for Wedding Photography Coverage**

This agreement is between (photographer) (hereinafter "Photographer"), and (client), (hereinafter "Client"), relating to client's wedding which will take place on (date).

**1. Photographic Services and Products.** Photographer shall provide the following: 8 hours of wedding day coverage, 4x6 proof prints, high resolution digital files, reprint release, 9x12 flush mount album with 60 images. The hours specified above are on a continuous basis. Overtime is charged at the rate of \$250/hour, prorated in 30 minute increments. Overtime charges are due prior to delivery of the proofs.

**2. Payment Policy.** A retainer of \$700 is deposited herewith to reserve event coverage on the above date and will be applied to the coverage price. Detailed charges are as follows:

**3. Cancellation.** Upon acceptance of these terms, Photographer reserves the time and date and will not make any other reservations for that date. For this reason, the retainer is non refundable, even if the Client cancels the order for photography, or changes the date of the wedding. However, if Photographer is able to contract another wedding assignment for the cancelled date, the full sum of the retainer will be refunded, minus an administrative fee of \$100.

**4. Copyright.** As the author of all images made hereunder, Photographer retains full copyright to all images provided, per U.S.C. Title 17 (U.S. Copyright Law). Client agrees that Photographer is free to use all images and/or reproductions for advertising, display, contest entry, publication or other purposes. Client has permission to make unlimited copies and reprints of all images from the high-resolution DVD provided to her, for personal use only. The high-resolution DVD shall contain the same images as the wedding day proofs presented to Client.

**5. Officiant and Venue Restrictions.** Photographer may be limited by the guidelines or rules of the ceremony official, ceremony venue, or reception venue. Client understands and agrees that Photographer will abide by such guidelines or rules and that they are outside the control of Photographer. Client agrees to hold Photographer harmless for the impact such guidelines or rules may have on the finished product.

**6. Exclusivity.** Client acknowledges that Photographer shall be the sole and exclusive professional photographers for the contracted wedding. Client further acknowledges that Photographer is not responsible for the impact on the final product of any interference during the photography process by guests or other vendors.

**7. Limitation of Liability.** While every reasonable effort will be made to produce and deliver outstanding images of the wedding events, Photographer's entire liability to Client for any claim, loss, damage, or injury arising under or relating to this Agreement or Photographer's performance hereunder, including the negligence of Photographer, is limited to a refund to Client of all fees paid for services. Because a wedding is an uncontrolled event, we cannot guarantee delivery of any specific image(s). In the unlikely event that Photographer is unable to provide the photographic services for any reason including, but not limited to, illness, injury, or act of God, Photographer will make every effort to secure a replacement photographer acceptable to Client. If an acceptable replacement is not found, Photographer shall immediately refund all monies paid, including the retainer.
